



RULES 33rd TROFEU BORRUFÀ

ARTICLE 1: OBJECTS OF AND ORGANISING INSTITUTIONS

The Trofeu Borrufa, placed in Andorra is an international children's ski competition, set up for U14 and U16 categories of the different ski federations under the International Ski Federation (FIS), which includes the disciplines of Super Giant (SG), Giant Slalom (GS), Slalom (SL) and Nation Team Event (NTE).

The Trofeu Borrufa is organized by Andorra Ski Federation and Ordino Arcalís Ski Resort, with the institutional support of the Andorra Government and the Honourable Comú d'Ordino.

The 33rd Trofeu Borrufa shall take place from the 27th to the 30th January 2025, with the following program:

This program might be modified according to the technical conditions of the slopes and the meteorological conditions.

ARTICLE 2: CATEGORIES AND RUNS

For the year 2025 the masculine and feminine categories are as follow:

U14: born between 2011 and 2012

U16: born between 2009 and 2010

The runs shall be traced according to the dispositions in force of the FIS's International Technical Rules (RIS), same for the material of the racers.

ARTICLE 3: PARTICIPATION

All official teams designated by their National Federations can participate in the *33rd Trofeu Borrufa*.

All the participants must be previously registered in their federation, which is, in charge of authorising the participation of their members.

All racers and members of the registered teams must be covered by a federative insurance.

All federations shall cover the medical expenses in case of accident of any of the members of the team they've registered.

Likewise, the federation shall make sure that their members respect all FIS rules and the rules here in above.

Andorra as the host nation of *The Trofeu Borrufa* reserves the right to authorize the participation of a second team for the other federations. (Ski pass free for the second team).

Each participating team shall be composed by 10 racers maximum and according to the following order:

U14: 4 racers + U16: 6 racers (with maximum 4 racers of the same sex) = 10 racers.

***The Organising Committee will only cover the expenses for one team of 10 racers.**

3.1. REGISTRATION

To formalize the team's registration, each federation shall duly fulfil the following attached forms:

FIS Entry Form Borrufa 2025 + Transfer Details 2025 and mail them to

borrufa@grandvaliraresorts.com

The Entry Form shall only be sent by the corresponding federations.

To facilitate the organizational tasks, please send the Entry Form before the 1st of January 2025.

The registration period shall be officially closed on January 10th at 5pm.

It is essential to correctly fulfil the Entry Form with the surnames, name, date of birth and the disciplines in which each racer shall participate. It is only necessary to fill in one Entry Form for the women (U14 and U16, with the disciplines in which they'll compete) **and one Entry Form for men (U14 and U16 with the disciplines in which they'll compete), and in which order you want them to be registered in the draws (Ranking).**

It's extremely important that all racers are listed in the Entry Form with the preferred order.

No changes shall be accepted during the team captains meeting.

The bib numbers and start lists will be given after the Team Captain Meeting, except for the U16 second race that will be given after the public draw.

Andorra, the organizing country of the "Trofeu Borrufa" allow nationals officials racers of the Andorran NSA (FAE), which are not listed in the officials A and B teams of the "Trofeu Borrufa 2025, to participate in at this event.

The starting order of these racers will be drawn, just after the last group of all Team B racers of every participant country. In cases where one of these racers scored, the points obtained will not be added to the Andorran teams.

3.2. MEANS OF TRANSPORT

The Trofeu Borrufa offers a free shuttle service from the Airport of Barcelona to the Principality of Andorra and from the Principality of Andorra to the Airport, only the 26th and 31st January respectively.

Daily and according to the schedule, there will be a bus service that shall allow the participants to go from their accommodation to the ski slopes.

When all the teams arrive to Ordino, they shall have to go to the Borrufa Welcome Point to deliver their documentation (passports), to formalize their registration and to collect the information of the Trophy.

3.3. ACCOMMODATIONS

In accordance with the FIS rules, each delegation shall enjoy free accommodation for one team and according to the following table:

- **Teams of 1 to 3 racers: 1 coach**
- **Teams of 4 to 5 racers: 2 coaches (or 1 coach and 1 assistant)**
- **Teams of 6 to 10 racers: 3 coaches (or 2 coaches and 1 assistant)**

The accommodation on half board provided by the organization and includes the afore mentioned below. Any other expenses shall be paid by the team:

- The stay on half board from Sunday 26th January in the afternoon until Friday 30th January in the morning.
- The lunch at the ski resort from the 27th to the 30th of January.
- A badge that authorizes the holder to freely use the ski lifts (ski pass) from the 27th to the 30th of January.

Accommodation of the second teams shall be settled by the federations that they represent, at the time of registration. (Free ski pass for the second team as well).

The Trofeu Borrufa shall coordinate accommodation of the second teams so that both teams of the same federation stay in the same establishment if it is possible.

ARTICLE 4: CLASSIFICATIONS

Each race and each category establishes an individual classification, men's and women's. It also establishes a team's classification, by adding the total points awarded to each racer in the individual classification in each and every competition of the program, men's and women's alike and according to the following list:

1st = 25 points / 2nd = 20 points / 3rd = 15 points / 4th = 12 points / 5th = 11 points / 6th = 10 points / 7th = 9 points / 8th = 8 points / 9th = 7 points / 10th = 6 points / 11th = 5 points / 12th = 4 points / 13th = 3 points / 14th = 2 points / 15th = 1 point.

In case of a draw in the classification, the winning team shall be the one whose participants have obtained a larger number of victories or has reached a better position in the classification.

4.1. COMPLAINS

Any claim must be submitted in writing, within 15 minutes after the disqualifications are announced, as established in the International Competition Rules (RIS).

4.2. SANCTIONS

The teams that do not respect the Race Rules established by the *33rd Trofeu Borrufa* shall be penalised.

ARTICLE 5: PRIZES

Men's and Women's Individual titles and with placings between 1st to 5th positions shall be awarded trophies.

The 33rd Trofeu Borrufa shall be awarded to the team that finishes in the first position of the combined classification of all the races.

ARTICLE 6: RESPONSIBILITIES

The Trofeu Borrufa is covered by an insurance subscribed to by Ordino Arcalís Ski Resort, as stated in the FIS Rules.

ARTICLE 7: UNFORESEEN MATTERS

For those unforeseen matters in the present 2025 Regulations, please refer to the FIS Technical Rules (RIS).

During the race persons who are neither part of the organization nor duly accredited to the Trofeu Borrufa are not permitted on to the racing slopes.

Neither parents nor families of racers are allowed to go on to the race slopes at any time.

All the participants have to respect the ski resort's safety rules.

The racers must properly inspect the course but are not allowed to train on it.

All participants must carry their Identity Cards and Ski Lift pass.

Other sanctioned behaviours:

Any intentional damage caused by the participants in any of the Borrufa's areas or the ski resort will result in a form of penalty and may even result in complete disqualification from the *2025 Trofeu Borrufa*.

Any intentional damage caused by the participants in any of the Borrufa's areas or the ski resort shall be paid either by their trainers or their teams.

All the expenses not covered by the *Trofeu Borrufa* shall be paid by the team or the trainers.

Disrespectful attitudes by the racers and the trainers towards other participants or committee members shall not be accepted and may result in penalties.
